## ***“Advances, Recent Trends and Knowledge Gaps in Forced Migration and Refugee Research in and on Turkey”***

For long, Turkey has been receiving forced migrants from near and far afield. From the early 2000s Turkey went through a migration transition and has now become an immigration country. Most notably, a decade ago, several million Syrian refugees began arriving in Turkey. Around that time a new Asylum and Migration Bureau was set up to prepare the modernisation of Turkey’s migration legislation and administration. These developments also put Turkey at the top of the migration research agenda; in 2011, the first TurkMiS workshop took place in Oxford to encourage and strengthen research into these developments. Meanwhile, academics concerned with migration matters related to Turkey are contributing in an important way to international scholarship. This workshop aims to look back at the achievements made over the past decade of knowledge production and migration management, promote recent advances, further enhance international knowledge transfer and cooperation whilst identifying certain distortions as well as knowledge gaps and consider ways forward.

This workshop is organised in collaboration with the Institute for Migration Research and Intercultural Studies ([IMIS](#), Osnabruck University), Migration Policy Centre ([GPM](#), Ankara Yıldırım Beyazıt University) and the Turkish-German exchange project on the integration of Syrian refugees into host communities in Turkey ([GIZ](#)), which is commissioned by the Federal Ministry for Economic Cooperation and Development (BMZ) and implemented by the Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ). The workshop takes place in the context of the “Forced Migration and Refugee Studies: Networking and Knowledge Transfer” project ([FFVT](#)), sponsored by the German Federal Ministry for Education and Research (BMBF).
